THE GUJARAT CO-OPERATIVE SOCIETIES ACT, 1961.

No. GHKH- 59 -2009-CMT-10-2003-5186-G-(P.F.I): Whereas certain draft of a notification which is proposed to issue under section 168 read with section 75 A of the Gujarat Co-operative Societies Act,1961(Guj. X of 1962) is published as required by sub-section (3) of the said section 168 at pages 279-1 to 279-2 of Gujarat Government Gazette,Extra Ordinary, Part IV-B dated the 29th July,2009 under Government Notification Agriculture and Cooperation Department No. GHKH-39-2009-CMT-10-2003-5186-G-(P.F.I) dated the 29th July,2009 inviting objections and suggestions from all persons likely to be affected thereby within thirty days from the date of publication of the said notification in the *Official Gazette*.

AND WHEREAS objections or suggestions received from the public on the said draft have been considered by the Government.

NOW THEREFORE, in exercise of the powers conferred by section 75A read with section 168 of the Gujarat Co-operative Societies Act, 1961 (Guj. X of 1962), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Co-operative Societies Rules, 1965, namely:-

- 1. These rules may be called the Gujarat Co-operative Societies (Amendment) Rules, 2009.
- 2. In the Gujarat Co-operative Societies Rules, 1965, in rule 34-A, for the existing Table the following shall be substituted, namely:-.
